Technical Assistance

Since June of 1999, our founding year, we have had 682 total requests for information or assistance for an average of 34 requests a year we have fielded. In 2018-19, we fielded 27 requests for assistance (compared to 40 in the same period last year). Of these:

- 11 of these were suspected violations of the law – 6 of the 11 were indeed violations and all changed their RFQ or bidding document. 5 of these were looked at and determined not to be violations (either because it was design build, QBS was used or violation of Brooks Act but not state law)
- 10 requests were from agencies asking for general information/interpretations or to help them comply before the RFQ was written or for interpretations. The majority had to do with a phased/associated project or a hiring roster.
- 3 concerned the Brooks Act
- 3 requests were for education or a presentation

Of these requests (details are available upon request):

- 12 concerned engineering services (45%)
- 6 concerned architectural services (23%)
- 5 concerned land surveying services (19%)
- 0 concerned landscape architectural services
- 0 concerned construction management
- 2 were general requests involving all disciplines (9%)
- 1 involved planning services (4%)

Services:

- We provided training
- We provided QBS education to all those who contacted us

Funding:

Currently we are funded by the following resources per year:

- AIA - \$1000 (13%)
